## 1. POCSO POLICY AND PROCEDURE:-

POCSO committee at school provides protection to all children (including male and female) from the offences of sexual assault, sexual harassment and pornography. The committee ensures healthy physical, emotional and social development of the child and protect children from offences of sexual assaults and sexual harassment, and for the matters concerning, protection of Children from sexual offences Act, 2012, notified by the Government of India.

## 2. INTERNAL COMPLAINT COMMITTEE- POLICY AND PROCEDURE

Internal Complaint Committee ensures protection of women at workplace, from sexual harassment. The committee ensures proactive measures, prohibition and redressal of any concerns faced by women at their workplace in context of sexual harassment. This committee is based on the guidelines provided by honourable Supreme Court which were provided for the first time, after the recognition of a case, wherein women's fundamental rights at workplace were violated.

The guidelines of honourable supreme court are subject to all workplaces, until any other legislation is passed in this regard. An Act to provide protection against sexual harassment of women at workplace and for the prevention and redressal of complaints of sexual harassment and for matters connected therewith or incidental thereto. Notification: 9th December, 2013, vide notification No.
